The Need

The Initiative

The iSCAN Goals

- To develop new IT standards and measures to promote the transferability and recognition of competences and qualifications in the IT security field in Europe.
- To design a certification standard specifically targeted to security for IT managers and staff.
- To enhance skills and competencies in latest IT security issues of IT managers in public organizations.
- To provide fully integrated and complete vocational training material for IT security specialists and managers of the public sector in the area of information security.
- To enhance information security and public organizations' ability, individually and collectively, to respond to major information security problems.

- iSCAN will help public organizations reduce their corporate risk by training IT managers and staff to efficiently and effectively respond to security threats that endanger the organizations' smooth functioning.
- Promote best practices in information security management, notably in enterprises and organizations of the public sector.
- Support occupational and geographical mobility of IT managers and employees in Europe by demonstrating a competence in the area of security for IT professionals.
